25 Days of Giveaways Sweepstakes

- 1. NO PURCHASE, PAYMENT OR SUBMISSION TO SALES PRESENTATIONS NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
- 2. **Sponsor**: The Radio Flyer 25 Days of Giveaways Sweepstakes (the "Sweepstakes") is sponsored by The Radio Flyer Company (the "Sponsor").
- 3. **Official Rules**: These are the official rules (the "Official Rules") for the Sweepstakes. - 5. **Eligibility**: The Sweepstakes is open to legal residents of the 50 United States of America and District of Columbia and Canada (excluding residents of the Province of Quebec) who are 18 years of age or older, or the age or majority in the jurisdiction in which they reside, whichever is older, at the time of entry. - 7. **Determination of the winner**: One (1) grand prize winner for each day will be randomly selected from those eligible entries received each day of the sweepstakes. A Provisional Winner for each day will be selected on or about ten (10) days after the end of the daily drawing (the "Drawing Date"). The Provisional Winner will be notified by phone or email. If the Provisional Winner does not respond within fourteen (14) days of the date appearing on the prize notification, or fails to comply with the instructions contained in the prize notification within that time period, Sponsor reserves the right to randomly choose an alternate winner from the pool of remaining eligible entries. The first eligible Provisional Winner that Sponsor successfully contacts in person by telephone or by email and who claims the Grand Prize in accordance with these Official Rules will be declared the final Winner. The Winner may waive the right to receive a prize. The return of any prize,
